NARRATIVE DESCRIPTION

A new proposed law to Chapter 249 of the Village Code entitled “**Removal of Utility Poles**”.

The proposed action is the adoption of a local law that would require local utility companies to remove inactive, damaged, unnecessary utility poles. The removal of the existing “double poles” is intended to improve public safety and to improve overall community character. This action is consistent with the Town's land use plan and zoning regulations, and will have no negative impact on the Town’s environmental resources.
